Hardship (EN) Notwithstanding any clause to the contrary, if the performance or timely performance of the contractual obligations is rendered temporarily impossible or excessively onerous due to any circumstance, the consequences of which were not fully foreseeable at the time of the commercial negotiations leading to the conclusion of the Contract (such as, but not limited to, partial or total crop failure due to climatic events or diseases affecting crops or agricultural raw materials, epidemics, parasites, radioactivity, prevailing in the region where Lutosa purchases its raw materials, shortage of raw material due to an event beyond the reasonable control of Lutosa and Lutosa's main suppliers and partners, pandemic, embargo/trade sanction or war having a major impact on the European economic market, energy cost increases, energy disruption or energy shutdown, or any other event beyond the reasonable control of Lutosa), but which result in: (i) Difficulties in sourcing the raw materials, ingredients, equipment or packaging necessary to manufacture your products; (ii) transportation issues; (iii) high absenteeism in our offices and/or factories where the Products are manufactured; (iv) total or partial closure of the factory or factories where your Products are manufactured, whether based on a decision of a governmental authority or not; (v) in the case of products manufactured by a third party, supply difficulties of such a third party (vi) significant inflation in agricultural raw materials, industrial raw materials or the main inputs required to supply the Products that disrupts the economic equilibrium of the Contract Lutosa undertakes to inform the Customer in writing (letter or email). The Parties then undertake to discuss this to try to find an amicable solution, negotiated in good faith and in the common interest of both Parties; including negotiating a revision of the agreed price. In the event of refusal or failure of negotiations to find an amicable solution (including price revision, if applicable) within one (1) month of Lutosa's request, Lutosa shall have the option of either (i) continuing the commercial relationship under the conditions initially set out in the Contract or (ii) terminating the Contract subject to a three (3) month notice period. Such termination shall be notified by registered letter with acknowledgement of receipt. In any event, Lutosa shall not be liable for any direct, indirect or consequential damages, nor for any operating losses, lost business opportunities or any other losses that the Customer may suffer as a result of these circumstances. The Parties further agree that no contractual penalty or compensation, for delay or non-performance, shall be payable by Lutosa as a result of such circumstances duly notified by Lutosa.

Price Revision (EN) Any offers made by the Seller never imply any commitment by the Seller. Offers are only binding after the express written confirmation of the Seller. The Seller reserves the right to update the price list at any time at its discretion. If the Seller and the purchaser have agreed to fix the prices against which the purchaser can order products during a certain period of time, but the costs for the Seller to supply the products are negatively impacted by any kind of event, the Seller reserves the right to increase this/these fixed price(s) in proportion to the increase of the cost price subject to providing fifteen (15) days advance notice of such a change to the purchaser. This applies in particular to the situation experienced in the energy and gas supply sector, such as for example, but not limited to, in the event that the gas supply is rationed, cut off, or the agreed contractual terms would not apply as intended, and including the application of underlying hedging agreements, directly or indirectly linked to actions by the government or suppliers or the economic situation.
